COMMITTEE UPDATES

September Speaker Highlights By Donna Rosenbaum

The Dayton Chapter of ICEAA started its 2015-16 program year with Ms. Cela Sweeney from MCR Federal LLC as its speaker. Ms. Sweeney's presentation "Modeling Schedule What-ifs to Develop Cost Impacts" provided practical examples as well as the schedule theory behind costing schedule impacts. A schedule can lay out the program with more accuracy and provide a better basis for spreading costs over the life of a program. According to Ms. Sweeney, the value stream flow should be: 1) requirements, 2) schedule, and then, 3) costs. Looking at the cost estimate in the light of the strong synergy between a program schedule and its cost provides a truer picture of the program costs and is more defensible.

Ms. Sweeney provided the following example of her point:

After 2 years of planning, the organic team dramatically increased the number of "install days" for each aircraft within 6 months of the 1st aircraft to start modification – extending the entire mod program (time x 1.5 x # aircraft in fleet).

The impacts in this scenario to the program are:

- Contracts (quantities per lot buy change)
- Required Assets Availability (RAA) dates change
- Initial Operating Capability (IOC) changes
- Program Office Estimates (POE) needs to capture changes in duration and associated additional resources
- President's Budget may change given program changes that now drive additional program iterations if funds are not available or not in the correct years

Using a template Ms. Sweeney has built in Microsoft Project she showed how she was able to adjust the schedule for the above impacts. Once the overall schedule incorporated the changed inputs, her model then allowed for new program cost estimates to be calculated.

The schedule template was built to assess the impacts of modified aircraft deliveries. Schedule assumptions were:

- First kit delivery 12 months after each contract award
- Kit delivery every 21 days after first kit delivery
- Kit breakout of 35 days
- Aircraft induction every 35 days
- "200+" days for each installation
- Flight crew flying days

Each assumption above was treated as a variable. It is also possible using Ms. Sweeney's template to incorporate various learning curves, multiple production lines (organic + contractor), various buy profiles and various contract award dates.

This Schedule/Cost Scenario tool has demonstrated its value and utility by assisting program managers in decision making on program impacts such as sequestration, budget cut drills, continuing resolution spending limits and speed-ups or delays in production.

Many of the questions Ms. Sweeney fielded dealt with the application of her model specifically and what had to exist in terms of a schedule or what needed to be built to make the tool function. Ms. Sweeney also talked about the time involved in using her model; what-if's can take several hours given the complexity and number of tasks in the schedule itself. The time and effort involved in doing this modeling has its rewards as Ms. Sweeny stated "schedules should be the framework for the cost estimates."

Pets for Vets is a registered 501(c)(3) nonprofit organization which gives shelter dogs a second chance at life while giving our returning soldiers a second chance at a health and happiness. These funds will go towards professional animal trainers rehabilitating the dogs and teaching them good manners to fit into the veteran's lifestyle. Training can also include desensitization to wheel chairs or crutches as well as recognizing panic or anxiety disorder behaviors. The bond that is formed between man and animal have the ability to ease the suffering of our troops when they are returning from overseas. More information to come.

- Annual Achievement <u>Technical</u>-Estimator making technical contributions to the profession
 - <u>Junior</u>: GS-12 and below, O-3 and below, comparable contractor experience
 - Senior: GS-13 and above, O-4 and above, comparable contractor experience
- **Annual Achievement** <u>Management</u>-Estimator making management contributions to the profession and exhibiting great leadership skills
- Parametrician of the Year-Estimator with focus on parametric model building or estimating
- Educator of the Year-Estimator making significant contributions to training and education

ICEAA Awards Guidance

In the selection of award recipients, the ICEAA Dayton Chapter Committee will take into consideration the individual's contributions to promote the purpose of ICEAA to improve cost estimating and analysis in government and industry and enhance the professional competence and achievements of its members by:

- Fostering the professional growth of its members within the allied fields of estimating and analysis.
- Enhancing the understanding and appreciation of using data-driven estimating and analysis techniques throughout allied fields and the general population.
- Providing educational opportunities to practitioners in cost and parametric estimating and analysis, as well as with allied fields.
- Establishing standards in terminology, conduct, and application of estimating and analysis techniques.
- Developing the means to achieve and measure established standards.
- Recognizing achievement through an appropriate program of recognition and certification.
- Providing forums and media through which experiences with all of the principles and techniques associated with data-driven cost estimating and analysis may be reported, discussed, and published in furtherance of the public interest.
- Fostering, promoting, and conducting research in all estimating and analysis techniques.
- Developing and maintaining standards of proficiency and ethics.
- Cooperating with other national and international organizations and individuals, having common or related proposes, in furtherance of the public interest.

The ICEAA Dayton Chapter Committee will follow these guidelines:

• Nomination format is left up to the submitter. Bullet-style or paragraph-style is appropriate. Format will not be a factor in nomination evaluation.

Awards Program (Continued)

- Any member of ICEAA may submit a nomination.
- The awards committee will categorize all nominations based on the award indicated on the nomination form.
- Only one of the following categories may be selected: ICEAA Service Award, Annual Achievement Technical (Junior or Senior level), Annual Achievement Management, Parametrician of the Year, Educator of the Year. If the awards committee believes a nomination should be categorized differently, the committee may change the category, with the concurrence of the nominator.
- The ICEAA Dayton Chapter committee may refuse to review data that cannot be verified easily.
- Nomination forms must not contain any proprietary or classified information.
- All nomination forms will be kept and maintained by the awards committee.
- Winning award submissions may be forwarded to the National ICEAA Awards Program.
